

The committee considered the request made by the institution for change of name of the institution from "**Rashtriya Sanskrit Sansthan (Deemed University) Rajeev Gandhi Campus, Sringeri, Karnataka**" to "**Central Sanskrit University, Rajeev Gandhi Campus, Sringeri, Karnataka**" in light of the Central Sanskrit Universities Act, 2020 notified in the Gazetted of India on 25.03.2020.

The Committee further directed to change in the records and website accordingly."

NOW THEREFORE, considering above decision in view necessary amendment be carried out in the records and website of NCTE as "**Rashtriya Sanskrit Sansthan (Deemed University)**" to "**Central Sanskrit University, Rajeev Gandhi Campus, Sringeri, Karnataka**".


